## Clarenceville Middle School Annual Education Report

Dear Parents and Community Members:

We are pleased to present you with the Annual Education Report (AER) which provides key information on the 2022-23 educational progress for the Clarenceville Middle School. The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about student assessment, accountability, and teacher quality. For the 2022-23 school year, schools were identified using definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that has at least one underperforming student subgroup. An Additional Targeted Support (ATS) school is one that had a student subgroup performing at the same level as the lowest 5% of all schools in the state in 2021-2022. A Comprehensive Support and Improvement (CSI) school is one whose performance is in the lowest 5% of all schools in the state or has a graduation rate at or below 67%. Some schools are not identified with any of these labels. In these cases, no label is given.

Our school does not have any labels. No subgroups fell below the threshold to be identified with any labels.

As indicated by the state assessment data, Clarenceville Middle School performed below-state-average in nearly every tested area with regard to the percentage of students who achieved proficiency, with the exception of 6<sup>th</sup> grade ELA in 2018-2019. We continue to strive towards meeting the learning needs of all students and to reduce/close achievement gaps. Our tiered intervention programming improved significantly in recent years, with the addition of a Tier II rotating intervention program in reading and mathematics. Our 2019-20 school improvement plan includes strategies for Tier I instructional improvements, and we have also added Tier II instruction with "push-in" support available during three hours of every school day.

Clarenceville Middle School continues to reflect, adapt, and modify our plan while looking at the various concepts of social-emotional (SEL) and the well-being of our students along with the Career Readiness initiative. We will continue to use FastBridge Assessments as our local indicator of student performance in Math and Reading. The numbers shown are the percentages of students who are considered to be at some risk in mathematics (as measured by the aMath assessment) and in reading (as measured by the aReading assessment).
